Authors are requested to include names and affiliations as well as their address, telephone number, fax and e-mail addresses. Please identify clearly the name of the contact author. **Four key words** and the **number of Conference Topic** (see above) of the paper should be indicated. Correspondence, papers and presentations should be in **English** and units should be **metric** only. Deadline for submission of the abstract is **January 8th, 2016**.

Review and Editorial

After review by the members of the scientific committee and acceptance of the draft manuscripts, the authors will be requested to submit the final version of their papers. Final acceptance will be based on the final paper and signing of the copyright agreement as well as registration and payment of the registration fees for the Symposium. Each accepted paper is expected to be presented and printed in a special issue of RMPD.
